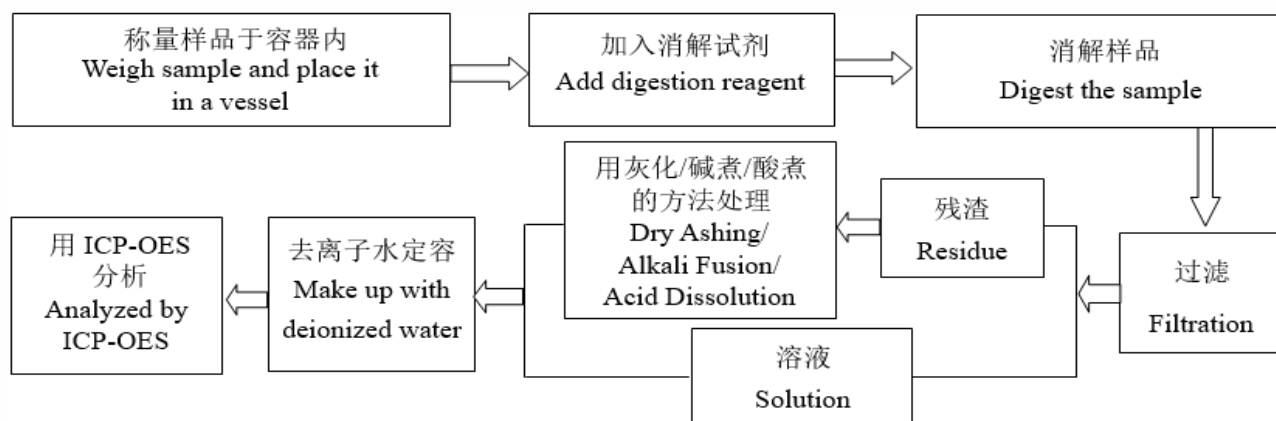

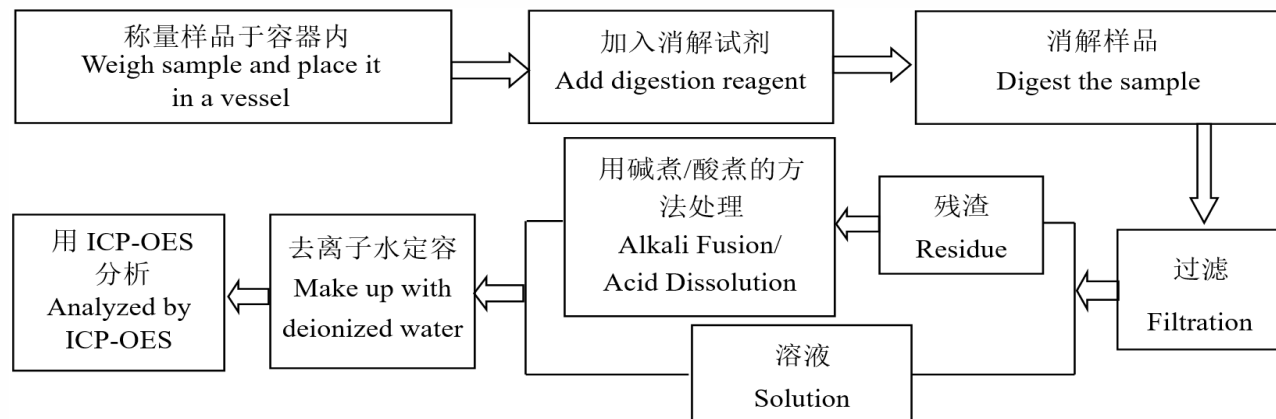

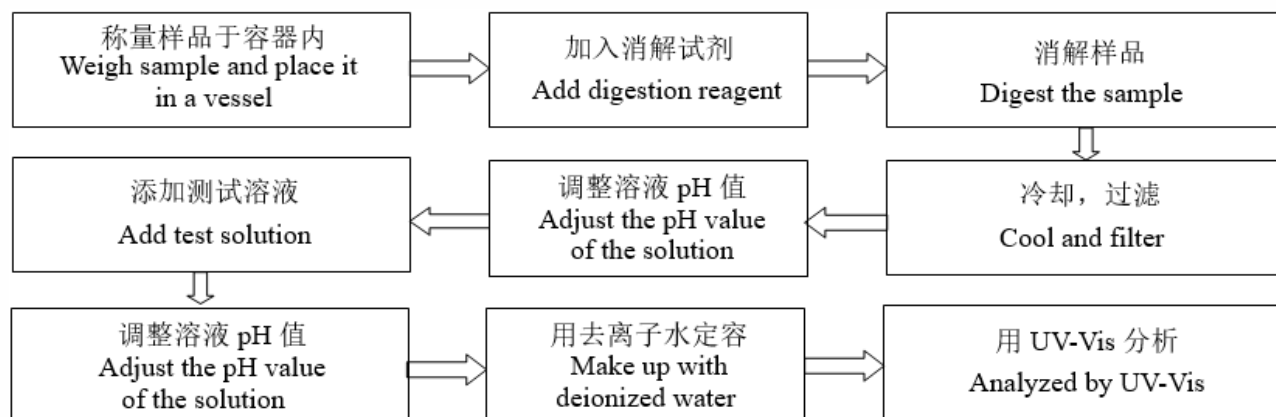
1. 铅 Lead (Pb), 镉 Cadmium (Cd), 铬 Chromium(Cr)

3. 六价铬 Hexavalent Chromium (Cr(VI))

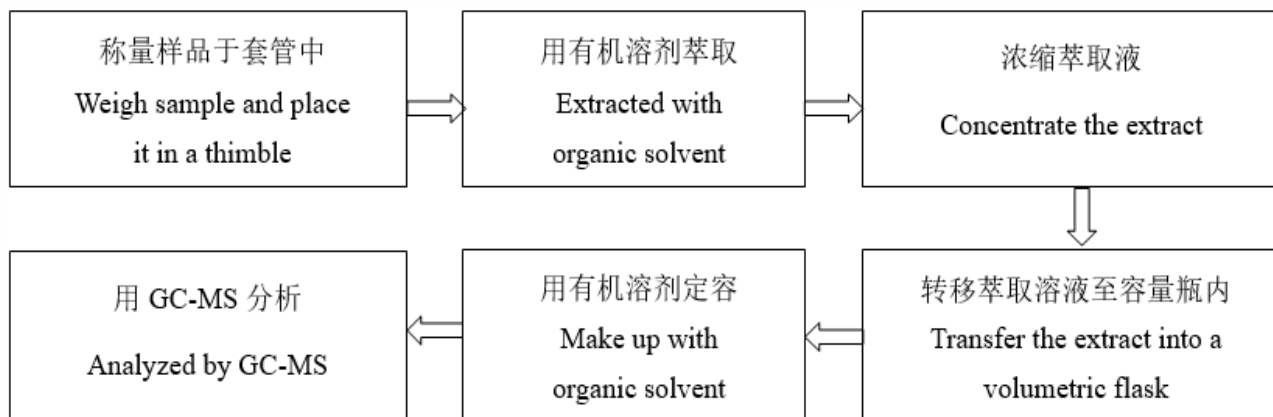

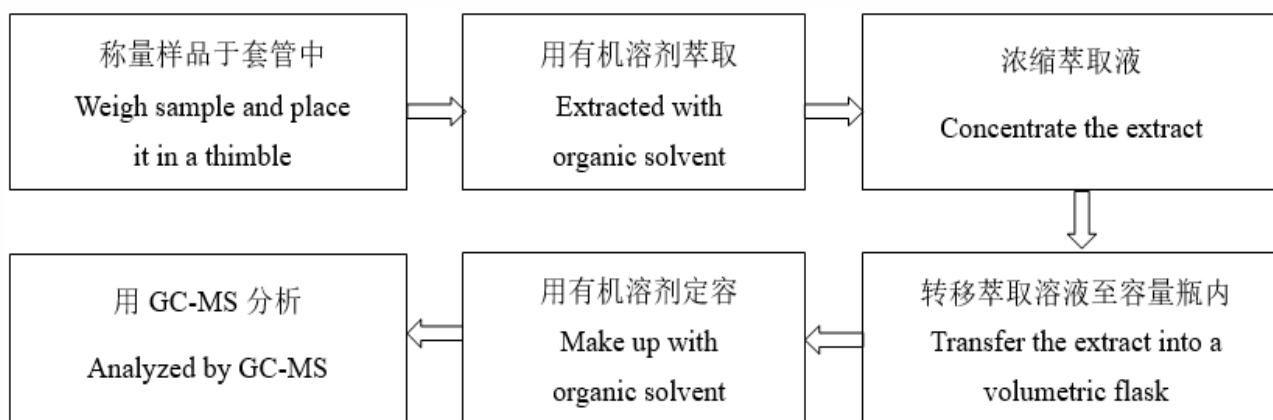
